Who we are and what we do

The East Sussex SAB is a multi-agency partnership of key statutory and voluntary agencies who work together to safeguard and protect adults with care and support needs.

Our shared vision is for all agencies to work together effectively to enable the citizens of East Sussex to live free from abuse and neglect, and to promote widely the message that safeguarding is everyone's business. Our members work together with local communities to ensure:

- There is zero tolerance to the abuse and neglect of adults;
- Empowerment and a Making Safeguarding Personal approach underpins all safeguarding adults work;
- People know what to do when abuse happens and how to report concerns.

Who we are and what we do - continued....

The Care Act 2014 outlined three core functions for a SAB:

- 1. Develop and publish a strategic plan setting out how we will meet our objectives and how our member and partner agencies will contribute.
- 2. Publish an annual report detailing how effective our work has been.
- 3. Commission Safeguarding Adults Reviews (SARs) for any cases meeting the criteria.

The SAB is chaired independently, meets four times a year and is supported by a number of subgroups that are crucial in ensuring that the priorities set out in the <u>SAB Strategic Plan</u> <u>2018 - 2021</u> are delivered. These subgroups ensure that the work of the Board really makes a difference to local safeguarding practice and to the outcomes adults and their carers wish to achieve.

News from the Board

Fast Sussex

The last Board meeting was held on 30th January 2020 and attended by over 20 members from organisations working with adults with care and support needs across East Sussex.

Below is a summary of the main items discussed at the meeting:

Voluntary and Community Sector (VCS) Representation

Work was undertaken during 2019 to expand the membership of the Safeguarding Community Network (SCN), one of the subgroups of the SAB. The purpose of the SCN is to bring together adult and carers, and community services with the aim of enabling a two-way exchange of information with the Board to improve safeguarding experiences and inform policy development. An update was provided at the meeting that six new members from the VCS network have recently joined the SCN, which includes representation from homelessness and veterans' charities, a family support group as well as health and wellbeing services. The Board looks forward to the valuable contributions these new members can make to supporting the work of the SCN.

Organisational Change Research Project



A report was presented to the Board outlining the learning from a research project undertaken by the University of Sussex, which the East Sussex SAB has participated in. The project has explored how existing research and findings from SARs involving self-neglect can be embedded into practice and how organisational change from this learning can be best facilitated. The SAB will be developing an action plan to respond to the recommendations made in the report. A briefing to provide an overview of the research project will also be published in the near future.

Operational Practice Subgroup Progress Report

The purpose of the Operational Practice Subgroup is to coordinate local safeguarding work and ensure that the priorities of the SAB are put into place operationally. The Chair of the Operational Practice Subgroup, Mark Stainton (Adult Social Care and Health, East Sussex County Council) presented a report highlighting key progress made by the group over the past year.

Key achievements include:

- Work to strengthen responses to concerns about Modern Slavery.
- The publication of the <u>revised self-neglect procedures</u> contained within the Sussex Safeguarding Adults Policy and Procedures.
- The launch of <u>Guidance on Raising Concerns about Abuse and Neglect</u>, which is designed to assist agencies in considering risk relating to potential safeguarding concerns and enables safeguarding concerns to be reported in a consistent way.
- The publication of <u>Mental Capacity Act Policy and Procedures</u>, which provides guidance on the understanding of the Mental Capacity Act and its application in practice.
- The completion of all recommendations set out within the <u>Financial Abuse Strategy</u> action plan. This has included publication of multi-agency guidance, a toolkit and screening tool.

Information Sharing Protocol

An updated Information Sharing Guidance and Protocol was presented to the SAB for agreement. Discussions will be taken forward over forthcoming months to consider developing this into a pan-Sussex protocol.

Peer Challenge and Support

In July 2019 a Sussex-wide peer challenge event took place, in which SAB partner agencies were asked to report on how they are meeting key standards in relation to safeguarding adults and to identify any areas for improvement. Progress of the action plan was reported to the Board and reflected that several actions have been completed since the previous Board meeting.



Future events - SAB Business Development Day

In March 2020 we will be holding a business development day to reflect on the past twelve months, and to look at the priorities that will be included in our next Strategic Plan 2022 – 2025. The planning for this event will also consider the feedback provided by SAB partners at the last meeting in October 2019 regarding how we can promote broader engagement from all partners in the work and activity of the Board activity.

Safeguarding Adults Reviews (SARs)

SABs have a statutory duty under the Care Act to undertake Safeguarding Adults Reviews (SARs) – formerly known as Serious Case Reviews. This is when:

- An adult dies as a result of abuse or neglect, whether known or suspected, and there
 is concern that partner agencies could have worked more effectively to protect the
 adult.
- An adult is still alive but has experienced serious abuse or neglect and there is concern that partner agencies could have worked more effectively to protect the adult.

The purpose of having a SAR is to consider any lessons to be learnt from the circumstances of the case regarding: the ways in which professionals and agencies work together to safeguard adults, review the effectiveness of procedures, and highlight good practice.

Updates on current SAR activity were provided to the Board meeting on 30th January, and findings from these reviews will be shared in future newsletters.



SAB Multi-Agency Audits



On behalf of the East Sussex SAB, the Performance, Quality and Audit Subgroup is responsible for the co-ordination and management of multi-agency audits and aims to undertake two themed audits per year. In 2019 a multi-agency audit was completed in relation to young people at risk of exploitation, with the purpose of the audit being to assess the effectiveness of multi-agency responses in this area.

A <u>learning briefing</u> has been produced to summarise the key findings and includes guidance and resources for staff who work with children and young adults who are at risk of exploitation.

SAB Learning and Development Opportunities



The East Sussex SAB provides a well attended training program which covers a range of safeguarding topics, including e-learning and face to face courses. These courses are open to staff from a range of agencies who provide services to residents of East Sussex.

Spotlight on.... Making Safeguarding Personal



The Local Government Association (LGA) published a briefing in December 2019 entitled <u>'Myths and Realities about Making</u> <u>Safeguarding Personal'</u>. The briefing has been developed to address misconceptions and a superficial understanding about Making Safeguarding Personal, and to caution those who interpret this approach simplistically. It supports and promotes relationship and strengths-based approaches in practice. It acknowledges the complexity of people's lives and challenges for practitioners to enable people (with representation or advocates, if they lack mental capacity) to keep themselves safe and safeguarded, and to achieve resolution and recovery in their lives.

The purpose of the briefing is to expose some 'myths' about Making Safeguarding Personal, which is not just about safeguarding practice, but also about prevention and strategic as well as operational safeguarding.

The briefing is aimed at front-line practitioners and operational managers that have a role in safeguarding adults. It is aimed at leaders at all levels and local councillors. It can also be used by anyone interested or involved in safeguarding adults. We encourage you to use this briefing as a prompt for discussions within your own organisations, maybe within supervision or team meetings.

Raising a Safeguarding Concern

No-one should have to live with abuse or neglect – it is always wrong, whatever the circumstances. Anybody can raise a safeguarding concern for themselves or another person. Do not assume that someone else is doing something about the situation.
