Safeguarding Adults Week is an opportunity for organisations from a range of sectors to join forces to:

- Raise awareness of important safeguarding key issues.

Regulation 28: REPORT TO PREVENT FUTURE DEATHS

This <u>Regulation 28 report</u> was issued following a fire death in Rottingdean on the 23/12/22. The Regulation 28 report relates to the Telecare system that was installed in this sheltered home, and the occupant's inability to summon help following her fall because she wasn't in possession of the alarm pendant.

This report reinforces the importance of reminding people with Telecare systems to ensure they keep the alarm pendant / bracelet on them at all times.

East Sussex Fire & Rescue Service (ESFRS) offer free Home Safety Visits for vulnerable occupants to reduce risk within the home. ESFRS also offer a short fire



 $\underline{\mathsf{safety}}\ \mathsf{awareness}\ \mathsf{session}$ for frontline staff to assist them to recognise potential fire risk .

Modern Slavery

The care sector is susceptible to worker exploitation and modern slavery. Many people providing their labour in the sector receive low pay and the work is considered low-skilled. Due to the transient nature of the workforce and the historic reliance on migrant workers, current labour shortages have created a further opportunity for workers to be exploited. Read the report 'who cares' by Unseen.

The University Of Nottingham Rights Lab have also recently published a commissioning officers guide regarding 'Establishing modern slavery risk assessment and due diligence in Adult Social Care'. This guide is aimed at commissioning officers and managers within local authority adult social care teams. It provides advice on to how to set up effective local systems to identify and manage the risks of modern slavery in adult social care.

Information Guidance

<u>Multi-Agency Domestic Abuse Guidance – East Sussex SAB –</u>This guidance has been developed to support all staff and managers working across agencies in East Sussex who support adults who are at risk of or experiencing domestic abuse. It provides a framework for a consistent and effective response to tackling this complex area of safeguarding practice.

<u>Sussex Safeguarding Adults Escalation and Resolution Protocol – East Sussex SAB –</u> This protocol provides an escalation and resolution process for disagreements between agencies or professionals in relation to adult safeguarding, including organisational safeguarding processes.

<u>Partnership Protocol 2022 – 24 – East Sussex SAB –</u> The East Sussex Partnership Protocol governs relationships between key agencies working to promote the health and wellbeing of East Sussex's communities.

<u>Multi-agency guidance for adults experiencing or at risk of financial abuse – East Sussex SAB</u> – The purpose of this guidance is to support all statutory and voluntary agencies in East Sussex who may have contact or an active role with adults who have experienced, or are at risk of, financial abuse. It also considers young people aged 16 – 17 who are transitioning to adult services, or experiencing domestic abuse.
